## Transported Semen Contract

This agreement is entered into on the date recorded below by the duly qualified member of "STALLION OWNER", Roger Landis, known as 'STALLION MANAGER' and the 'MARE OWNER' whose name or signature appears below. All parties agree that they have executed a breeding contract to breed the mare named below to the stallion. In addition to the duties placed upon all parties to the breeding contract, it is mutually agreed by all parties that good and sufficient consideration exists to execute transported cooled semen agreement for the breeding season mentioned below.

All parties agree that every semen shipment to the MARE OWNER shall be at a cost of **\$325.00. Canadian shipments are \$375.00 US and the cost of Export Documents. Use of any frozen semen stored at a facility will be charged at \$300.00 per insemination. Mare owner must notify Breeding Farm prior to any usage of frozen semen.** If semen is needed the same day via an airline MARE OWNER will be responsible for the additional charge of **\$100.00 plus applicable courier fees. On site pick up is \$175.00.** All fees must be paid in advance of the shipment of semen or use of frozen semen. VISA and Master Card are accepted. In addition, prior to the first shipment of semen all breeding fees must be paid in full.

**1. Collection Days:** Collection days are *Monday, Wednesday, and Friday*. All shipping requests must be made by text or phone call only to 740-815-3545, with mare's registered name and address for shipment at the time of reservation. **Orders must be requested the day before a collection day by 7:00 PM (Eastern Standard Time) with a cancel or confirm the morning of a collection day no later than 7:00 AM (Eastern Standard Time).** A 24hr notice is required for any Counter-to-Counter shipment. Late orders will be serviced according to availability of semen.

**2. Shipment Limits:** Stallion owner reserves the right, at its sole discretion, to: (a) set a limit of 1 dose per mare per breeding cycle. We ask that all mares be set up properly for breeding. Should more than 3 shipments be requested for the same mare, the Stallion Owner may require a negative culture report to continue servicing the mare.

**3. Shipments:** Stallion Owner makes no warranty or guarantee, express or implied with respect to: (A) the semen, including but not limited to the warranty or fitness for a particular purpose; (B) the delivery of the semen within a certain time period or method; (C) that the semen will safely reach the insemination point without damage, viability, contamination or losing integrity, quality, or other characteristics; and (D) the services of any third party breeding facility.

**4. Delivery:** All parties to this agreement agree that the obligations of performance by the STALLION OWNER and the STALLION MANAGER shall be met when the chilled semen shipment leaves the Breeding Farm. NORTH FARM INC. is released from all claims when shipment has left the center. All parties to this agreement agree that the risk of loss transfers to the MARE OWNER after pick up.

The STALLION OWNER and the MARE OWNER shall execute a Breeders Certificate and shall comply with any parentage verification as required by the AQHA, or their respective breed association. This agreement is limited to the 2024 Breeding Season.
